Over the past 40 years, Cancer League of Colorado has raised over \$13 million to be used for cancer research. These funds have been disbursed to Colorado based research organizations, typically in the amount of \$30,000 to \$60,000. And in many cases, this seed funding has resulted in significant follow-on research funded by the Federal government, pharmaceutical companies and other organizations. Several years ago, Cancer League did a statistical analysis of a number of our prior grants awarded and determined that for every dollar granted by Cancer League of Colorado, another \$20 was granted through subsequent funding by larger organizations to continue the more promising investigations.
